Recently, I was reading some material on the Nuremberg Trials which followed the defeat of Germany in World War II. The book kept referencing a "Mr. Alderman" who read the charges to the court against many of the defendants. It got me to wondering who this "Mr. Alderman" might be and if he was related to our Aldermans. A quick check on the Internet revealed him as Sidney Sherrill Alderman (15-10-2-1 page 309 in *Aldermans in America*). His line is through Daniel Alderman (Column 15) and Mary P. Wilson who was Daniel's 4th wife- page 278. I encourage all of you to take a minute and read the entire narrative in the book. In 1945-1946, he served as Special Assistant to the Attorney General of the United States and assisted the late Associate Justice Robert H. Jackson of the US Supreme Court in the Four-Power negotiations, preparation, and prosecution of the case against the major Axis war criminals at the Nuremberg Trials. He later served in many capacities including several years as a trustee of Duke University.

The *Aldermans in America* book is loaded with information on our ancestors. We should all be proud of their accomplishments. Take time to read up on your family.

On another family member

We are still trying to locate a descendant of John Alderman and Elizabeth McDuffie (*Aldermans in America* page 189). We have a great photo of Margaret McDuffie the wife of Dougald McDuffie that needs to be in the family possession. Margaret was the mother of Elizabeth McDuffie who married John J. Alderman.
