ALDERMAN HISTORICAL ASSOCIATION – 2024 MEETING MINUTES

June 22, 2024

Meeting was called to order at 12:15 by Grover Ezzell at the Sampson County History Museum in Clinton, NC.

President Ezzell welcomed everyone and rendered the innovation prior to lunch.

Meeting was immediately adjourned for Lunch.

Meeting was called back to order at approximately 1:00pm.

President Grove Ezzell asked everyone to introduce themselves since we had some new attendees.

President Ezzell recognized our unique attendees:

President Ezzell called for the Secretary's Report

Secretary Alderman announced that he had forgot to bring the last set of minutes with him and appologized for the short coming. He will send them out after he returns home. He did cover a couple of items he remembered were discussed: the website situation and meeting locations.

President Ezzell called for the Treasurer's Report.

Susan Bland presented the Treasurer's report which was published in the Fall 2023 newsletter. She gave an update of expenses since that report and provided a copy to both President Ezzell and Secretary James Alderman. She mentioned that Matt Ezzell had started a lawn service business and was graciously taking care of the Alderman Cemetery at no cost to the Association. A question was asked if we donate to other ventures with our funds – Susan said we usually donate to the Sampson Museum facility for use during our reunion but no other major donations had been made in recent years. Jack Westberry asked about the need to reprint the Aldermans in America book. We have approximately 12- 15 copies left and it was announced that it is currently in the Public Domain and can be ordered via the web. Motion was made to accept the Treasurer's report by James Alderman and Jack Westberry then approved.

President Ezzell then asked Secretary Alderman to provide his presentation on the Alderman lineages. At the conclusion, President Ezzell thanked James for his efforts.

OLD Business -

President Ezzell asked if there were any known deaths since our last reunion. The passing of Jeff Ezzell's mother, Charlotte Ezzell, was noted as well as the passing of Barry Collins the husband of Nancy Collins.

James Alderman asked that everyone please help him keep our database up to date with names of any they know who pass away.

President Ezzell noted he has a new addition to our family group. James Alderman indicated that he has two new great grand children (twins) since last October. Their surnames are Lee through his daughter.

President Ezzell brought up the possibility of holding our 2025 reunion at the Moore's Creek Battlefield facility near Wilmington- Patriot's Hall. After discussion he was given approval to investigate the use of that facility for 2025.

The next topic of discussion was Election of Officers. Jack Westberry made the motion/seconded by James Alderman we keep the existing officers for another year. Motion was approved.

A question was asked about the upkeep of other Alderman Cemeteries in the area specifically the Oak Plains Cemetery. Matt Ezzell indicated that one other cemetery was being cared for by the local homeowner. No actions taken.

Secretary Alderman brought up the recent efforts by Kay Ezzell and himself regarding the resolution of the issues with our website. He and Kay have started discussions with a website person to see if the website can be brought back up to operation and updated. We should have some information in the coming week.

NEW Business

President Ezzell called for a motion to donate to the Sampson County History Museum for use of their facilities. Motion was approved.

President Ezzell suggested we approve a capped funding level for James and Kay to work with should the website need expenditure of funds to get it fixed. A cap of \$1200.00 was approved for us to work with should they need advance approval.

President Ezzell then asked Secretary Alderman to come forward to introduce some recognition for attendees. The Alderman "Challenge Coin" was introduced and he and James presented all direct lineage attendees with the coin. President Ezzell announced that the coin was an effort to improve Reunion attendance and for the next four years, we would present attendees (new) a coin as a keepsake. A photo was taken of all attendees receiving the coin at this reunion.

Some discussion was held regarding the participation of the Blanton family as their reunion tends to coincide with our reunion. Susan and James indicated they will contact some of them and see if we could get them to attend next year. A effort will be made to have Ronnie Alderman the son of J.B. Alderman attend next year.

The 2024 reunion location and date was established as June 28, 2025 with notice going out if the meeting site changes.

Everyone was encouraged to stay and mingle or take the museum tour.

Meeting was adjourned at 2:45 pm.
